Drone Survey Report:

As per the scope of work we have carried out Drone surveillance of entire sand ghat and it has been found that

- Pillar demarcation has been found proper.
- Pollution controlling activity such as dust suppression and plantation is being carried out.
- No mining is being done in river active channel.
- Safety distance has been left from the bank of the river.
- Mining is being done under allowable depth.
- Transportation of excavated material is being done in covered trucks/tractors.
- Transportation of sand is being done with all the safety procedures.
- No illegal sand mining has been found throughout the sand ghat.

CONCLUSION

This audit involved extensive consultation with all the persons working with or directly or indirectly associated with the mining activity, interactions with key personnel on wide range of issues related to Environmental aspects. The audit has identified several environmental friendly observations. The recommendations are also mentioned with some observations such as training conduction, occupational health officer appointment, repairing of haul roads activities. The audit team certify that the overall site is maintained well from environmental perspective. The proponent has assured to follow the compliance suggested by the audit team.

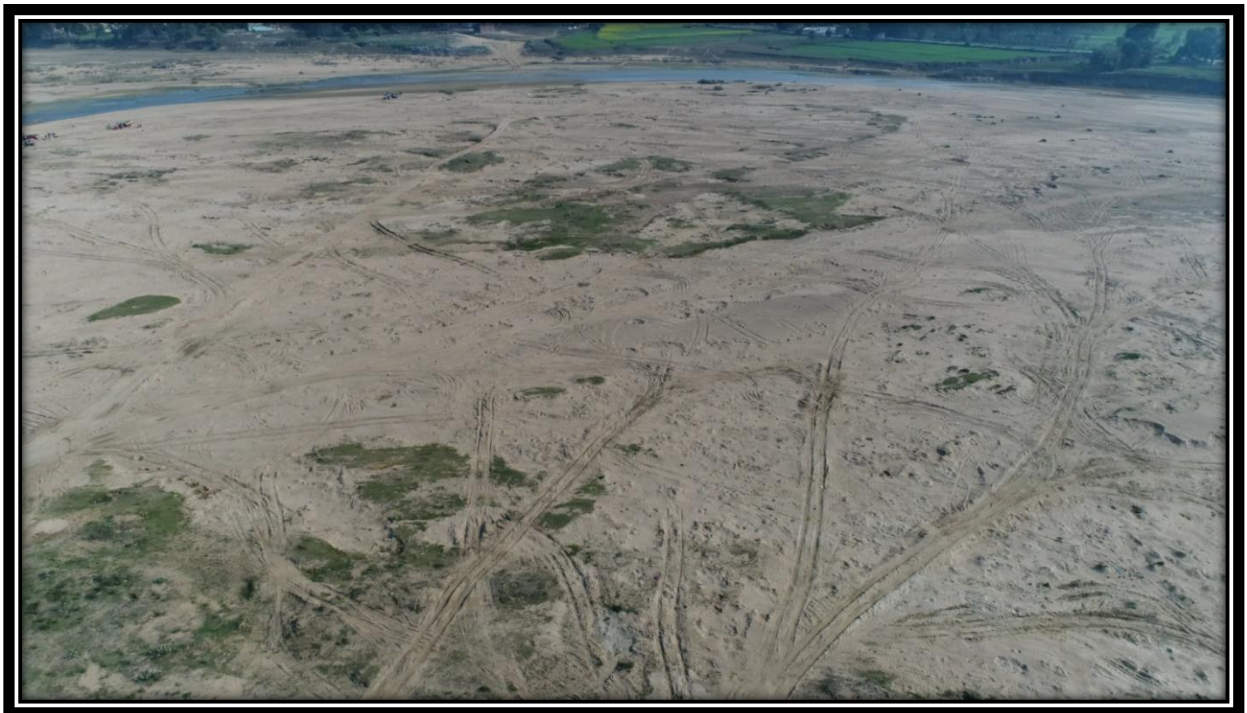

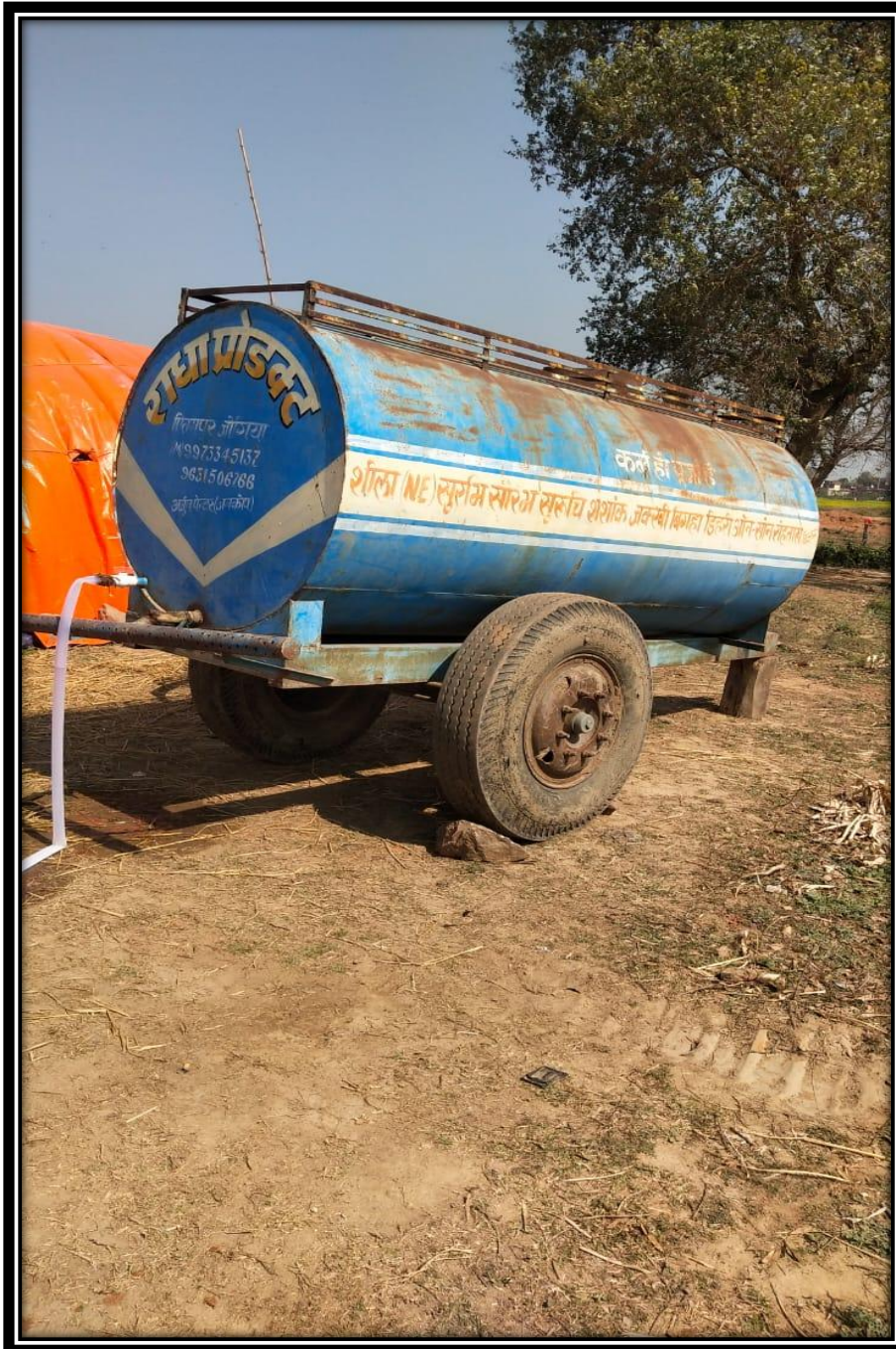
